

HATEFUL HILL R/C FLIERS

CONSTITUTION

SECTION 1. ALL PERSONS INTERESTED IN REMOTE CONTROL AIRCRAFT SHALL BE ELIGIBLE FOR MEMBERSHIP IN HATEFUL HILL R/C FLIERS.

NAME

SECTION 1. THE NAME OF THE CLUB WILL BE: "HATEFUL HILL R/C FLIERS".

PURPOSE

SECTION 1. THE PURPOSE OF THIS CLUB SHALL BE:

- A. *THE SAME AS THOSE STATED IN THE AMA BY-LAWS, AND TO GOVERN OURSELVES IN SUCH A FASHION AS NOT TO LOSE OUR FLYING SITES BY ADOPTING RULES FOR ALL MEMBERS TO FOLLOW.*

ORGANIZATION

SECTION 1. ELECTIVE OFFICERS OF THE CLUB SHALL BE PRESIDENT, VICE PRESIDENT, SECRETARY TREASURER AND THE FIELD MARSHALL.

THE OFFICE OF THE SECRETARY AND THE TREASURER MAY BE HELD BY THE SAME PERSON.

SECTION 2. DUTIES OF CLUB OFFICERS WILL BE AS FOLLOWS:

- A. *PRESIDENT – PRESIDES OVER ALL MEETINGS, SUPERVISES THE WORK OF ALL OF THE OTHER OFFICERS AND REPRESENTS THE CLUB.*
- B. *VICE PRESIDENT – AIDES THE PRESIDENT, AND TAKES THE PRESIDENTS' PLACE IF HE IS UNABLE TO PERFORM HIS DUTIES.*
- C. *SECRETARY – NOTIFIES THE MEMBERS OF TIME, PLACE AND PURPOSE OF ANY SCHEDULED, OR SPECIAL MEETING, KEEP AND READ THE MINUTES OF MEETINGS, AND HANDLE ALL CORRESPONDENCE FOR THE CLUB.*

D. TREASURER – HANDLES ALL CLUB FINANCES, AND KEEPS A RECORD OF INCOME AND EXPENSES. REPORT ON THIS AT EACH MEETING. NOT SPEND ANY CLUB FUNDS WITHOUT PRIOR APPROVAL OF THE PRESIDENT OR VICE-PRESIDENT.

E. FIELD-MARSHALL – ENFORCE THE RULES OF THE CLUB AT THE FLYING SITE OR EVENTS HELD BY THE CLUB.

SECTION 3. OFFICERS SHALL BE ELECTED BY A SIMPLE MAJORITY AT THE ANNUAL SPRING MEETING AND ASSUME THEIR DUTIES IMMEDIATELY FOLLOWING THE SPRING MEETING.

MEETINGS

SECTION 1. A REGULAR SPRING MEETING SHALL BE HELD AND ANY ADDITIONAL MEETINGS AS REQUIRED TO CONDUCT BUSINESS THAT MAY ARISE.

SECTION 2. SPECIAL MEETINGS MAY BE REQUESTED BY ANY OFFICER OR BY A MAJORITY OF THE CLUB MEMBERS. EACH MEMBER SHALL BE NOTIFIED OF TIME AND PLACE.

MEMBERSHIP AND DUES

SECTION 1. TO BE A MEMBER YOU MUST:

A. BE A CURRENT MEMBER OF THE AMA (ACADEMY OF MODEL AERONAUTICS).

B. APPLY FOR MEMBERSHIP WITH ONE OF THE CLUB OFFICERS.

C. PAY ANNUAL DUES

SECTION 2. DUES MAY BE SET AT THE ANNUAL SPRING MEETING OF EACH YEAR.

A. CURRENT DUES IS SET AT \$20.00 FOR A SINGLE MEMBERSHIP AND \$25.00 FOR A FAMILY MEMBERSHIP.
